A Message vide Radiogram No. 223/AB dated 13.03.2021 has been received from the Superintendent, Ranaghat Subsidiary Correctional Home intimating the custodial death of UTP RAJU BISWAS, S/o – MONI KUMAR BISWAS of Vill – PIPULBERIA, P.S. – HANSKHALI, DIST - NADIA. He was found hanging at Latrine of makeshift Kitchen ward inside the Ranaghat Subsidiary Correctional Home on 13.03.2021 at about 02:32 am. The Medical Officer of the Correctional Home declared him dead at 03:50 am on 13.03.2021.

The Superintendent of Police, Ranaghat Police District is directed to cause an enquiry and to submit a report by 30.04.2021 positively along with the enquiry report made by the Judicial Magistrate under section 176(1A) of the Cr. P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 30.04.2021.
