The Commissioner of Police, Chandan Nagar Police Commissionerate is directed to cause an enquiry and to submit a report along with the inquiry report made by the Judicial Magistrate under section 176(1A) of the Cr. P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC. He is also directed to submit Post Mortem Report, Surathal report and Magisterial Inquest Report by 19.05.2021.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of supporting documents by 19.05.2021.
