A Message vide Signal No. 556/AB dated 01.04.2021 has been received from the Superintendent, Burdwan Central Correctional Home intimating the custodial death of CONVICT TAPAN SINGH, S/o – Late Haradhan Singh, Vill – Ghospur, Melatal, P.S. –Khanakul, Dist – Hooghly. He committed suicide by hanging at Latrine inside the correctional Home on 01.04.2021 at 04:30 am to 04:40 am.

The Superintendent of Police, Purba Bardhaman is directed to cause an enquiry and to submit a report along with the inquiry report made by the Judicial Magistrate under section 176(1A) of the Cr. P.C. which is mandatory in view of the order dated 04.09.2020 passed by NHRC. He is also directed to submit Post Mortem Report, Surathal report and Magisterial Inquest Report by 31.05.2021.

The Director General of Correctional Services, West Bengal is also directed to submit a detailed report alongwith copy of supporting documents by 31.05.2021.
