The Controller of Vagrancy, West Bengal is also directed to submit a detailed report alongwith copy of Post Mortem report and Magisterial Inquest report etc. by 15.02.2021.

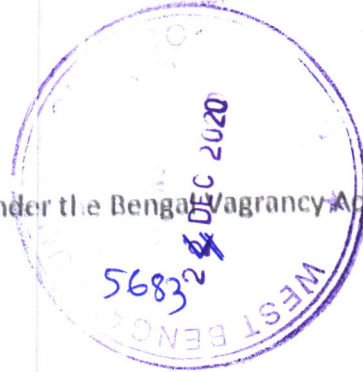

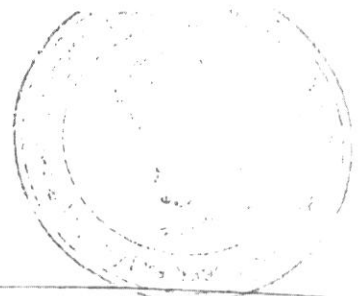
