Complainant Baby Ghosh alleged that the victim being her father's friend Sri Prabir Chatterjee a resident of an Old Age Home was suffering from various difficulties at the said Home and requested her to send letters to different authorities when he found that his personal documents like bank passbook, cheque book, pan card etc. were found missing from his almirah. She further alleged that all on a sudden she got an information that Sri Prabir Chatterjee was shifted elsewhere forcefully and accordingly she reported the matter to Haridevpur P.S. but police without relying upon her report was misguided by the owner of the said Home and even suspected about some ill motive of the complainant.

Considering the grievance of the complainant the Hon'ble Chairperson was pleased to direct the Investigation Wing of the Commission to conduct an enquiry and to submit a report by 30.04.2021.

The D.S.P.-II, WBHRC Sri Arun Mondal was directed to conduct the enquiry and he only made a prayer for extension of time on 30.04.2021 but did not submit the prayer before the Hon'ble Chairperson and ultimately without doing anything he handed over the file on 26.08.2021 for joining in his new posting on transfer when D.S.P.-I, WBHRC was absent. However DSP-I, WBHRC himself took the charge of enquiry and during enquiry he examined the victim, his co-resident, an worker of the said Home and the owner of the said Home, collected some supporting documents and snapped some photographs and made contact with the complainant also and submitted his report on 25.10.2021 and attached the relevant documents with the file with proper pagination.

It appears from the said report and supporting documents that the statement of the victim Prabir Chatterjee was duly signed by him and he stated therein that he had been residing at the said Home for a period of near about 6 years. He also stated that the documents which he thought to be missing were ultimately recovered from his almirah. In course of extensive searching it was found that those documents had been kept in an envelope. He further stated that he was only facing a problem for taking the pungent items being cooked at the said Home and save and except such problem, the service of the said Home was quite good and he had no allegation against the said Home the statement of the victim has been attached with the files as Page Nos.50 to 52. The statement of another resident of the said Home namely – Swapan Sen was also recorded. The said Swapan



Sen stated that the allegations made against the said Home were not correct. The statement of Swapan Sen duly signed by him is attached with the file as Page Nos. 41 and 42.

It is further reported that during enquiry the complainant was also contacted and she also stated that no document of victim was stolen and save and except illness, the victim was not facing any other problem. The complainant has also sent a letter to WBHRC under speed post stating all those facts. The said letter dated 22.09.2021 along with its enclosure and speed post cover are attached with this file as Page NOS.-61 to 66. Complainant prays for closure of the present case.

Thus during enquiry it is revealed that the whole problem<sup>was</sup> created due to some misunderstanding and at present the victim is living peacefully at the Home in question. Apart from that both the victim and the complainant have prayed for closure of the case.

Thus there is no scope to proceed further in this matter and the same may be disposed of subject to final decision of the Hon'ble Chairperson.
