## WEST BENGAL HUMAN RIGHTS COMMISSION

A news item appeared in The Statesman news paper dated April 05, 2020 "WITH NO INCOME OR HOPE RIKSHWPULLER LEFT HIGH AND DRY". The news item stated that due pandemic COVID-19 the Rickshaw-puller were facing serious financial crisis. They have not witnessed such crisis earlier. They have no place to sleep and facing food and money shortage. The General Secretary of Rickshaw-puller Union Shri Muktar Ali has already informed the matter to State Authorities.

ii) In view of seriousness of the situation the W.B. Human Rights Commission took suo-moto cognizance of the matter and directed A.D.G. of its investigating wing to enquire into the matter and submit report forthwith to the commission.

iii) The ADG, IW of WBHRC has since submitted the report to commission. According to the report it is absolutely correct that the Rickshaw-pullers who have earning Rs.250/- - Rs.350/- on an average per day but following lockdown their income become nil. A number of Rickshaw-puller from Bihar and Jharkhand had gone back to their native places but a large number of them are still concentrated in city areas like Barabazar, Jorabagan, Manicktala, C.R. Avenue, Shyambazar, A. J. C. Bose Road / Alimuddin Street, Bhawanipur, Ekbalbur, Taltala and Entally. The Secretary of Rickshaw-pullers Union, Najib Khan further informed that there is acute shortage of food and ration article and have informed the State Government. Moreover, they had no place to sleep and using Rickshaw for such purpose.

iv) The WBHRC considered the entire matter as a human rights issue and in view of the possibilities that the lockdown may continuing for a prolonged

period due to the pandemic, makes following recommendation to the State Government......

a) The State Government should immediately make a census of such stranded Rickshaw-pullers, and such other indigent persons area wise, who are facing acute food and other related crisis regarding shelter etc.

b) It is recommended that the Government should make arrangement for supply of food articles to such stranded Rickshawpullers including needy and indigent persons and also make arrangements for their stay in night shelters till the present lock down period is over.

v) Secretary and CEO of WBHRC is directed to send a copy of this recommendation to Chief Secretary, Government of West Bengal immediately. The Chief Secretary is directed to send an action taken report to commission within three months of receipt of recommendation. Ld Registrar is directed to upload a copy in the website.
