



The Superintendent of Railway Police, Siliguri is directed to furnish a detailed report on the incident to the Commission by 25<sup>th</sup> August, 2017.


The Commissioner for persons with disabilities, West Bengal is also directed to furnish a detailed report to the Commission by 25<sup>th</sup> August, 2017.

# Disabled woman, uncle kicked off train by GRP personnel

Siddiqa Parvin from Buniadpur in South Dinajpur who suffers from a growth disorder, and whose treatment was arranged by the chief minister Mamata Banerjee at the SSKM Hospital in Kolkata alleged that she and her uncle was forced to get down from Gour express link train last night by GRP Kolkata personnel from the coach for disabled people despite possessing a disabled certificate.

The woman and her uncle, Moktar Sheikh, waited for almost three hours and boarded another train at midnight to reach Kolkata for her treat-

ment. According to sources, these two were forced off the coach for the disabled by

some GRP personnel last night at Harirampur station for not bribing them. Her certificate of disability was also torn up by the policemen.

Mr Sheikh said, "We were literally thrown out of the coach by the GRP on duty and the certificate shown by Siddiqa did not matter to them."

No railway official in Malda town station was available to comment on the matter.
