Man dies in police custody

A 35 year old man died in police custody on Wednesday. The deceased is identified as Bechan Roy, a resident of Matigara in Siliguri. Police arrested him under Section 290 IPC today for allegedly selling liquor illegally. Police sources said Bechan was drunk and fell sick in Matigara police station. Police immediately brought him Matigara Block Hospital where doctors declared him

dead. After the death of Roy angry villagers staged an agitation in front of the police station this evening. Relatives alleged that Bechan died due to police torture. However, police denied the allegation. To prevent untoward incident a huge police force was deployed. Deputy Commissioner of Police, Zorie H, West, KB Singh rushed to the police station. A huge contingent of forces from other police stations was brought in to control the irate mob.
