On 30.01.17 this Hon'ble Commission took cognizance from the news clipping published in a Bengali daily "Ekdin" dt. 30.01.17 since it was reported in the said news clipping that a minor girl was raped and murdered and three persons were arrested in connection with that case. S.P., Bankura was directed to furnish a report.

On 02.02.17 S.P., Bankura forwarded a report made by the SDPO, Khatra and such report was made after an enquiry conducted by the said SDPO himself.

It is reported that initially a case was started on the allegation of kidnapping and the same was registered u/s 363/365 IPC and during investigation three accused persons namely Naran Bauri, Saraswati Duley and Mou Duley were arrested. Upon interrogation of the aforesaid accused persons it is learnt that Naran Bauri had an affairs with Saraswati Duley and Mou Duley, but later on a relationship was grown up between Naran Bauri and the victim which came to the knowledge of Saraswati and Mou and they asked Naran to commit the murder of the victim, otherwise they would cut off the relationship with him. It is also learnt that the victim also insisted Naran to marry her, but Naran was married having two daughters and one son and it was very difficult for him to marry the victim and as such he was also agreed to the proposal made by Saraswati and Mou and all of them chalked out a plan and they got the opportunity to commit murder of the victim in the wedding party held at their village. It is also learnt that Saraswati and Mou took the victim to a place adjacent to a pond, informing her that Naran promised to marry her and in this way they handed over the victim to Naran and he committed murder of the victim by strangulation after committing rape upon her and left the dead body on the bank of the said pond. It is reported that during interrogation the aforesaid accused persons confessed their guilt and accordingly Sec. 376/302/120B and Sec. 4 of POCSO Act, 2012 were added.

The case is now subjudice and as such the matter is filed as per order dt. 30.10.17 passed by the Hon'ble Commission.

এ বার ধর্ষিতার বাড়িতে আগুন

নিজস্ব সংবাদদাতা, জলপাইগুড়ি: ধর্ষণের অভিযোগ প্রত্যাহার করার হুমকি চলছিলই। কিন্তু তাতে কাজ না হওয়ায় এ বার ধর্ষণের শিকার তেরো বছরের মেয়েটির বাড়িতে আগুন দিয়ে পুড়িয়ে মারার চেষ্টার অভিযোগ উঠল জলপাইগুড়ির ময়নাগুড়িতে। শুক্রবার ভোর রাতে ওই ঘটনার পরে একজনকে আটক করেছে পুলিশ। তবে ধর্ষণে অভিযুক্ত যুবক এখনও অধরা।

গত ১১ নভেম্বর ওই নাবালিকাকে ধর্ষণের অভিযোগ উঠেছিল প্রতিবেশী যুবক শ্যামল মোহান্তর বিরুদ্ধে। এ দিনের অভিযোগের পর শ্যামলের দাদা অলোক বলেন, “তাঁদের ফাঁসাতে নাবালিকার বাবা-মা নিজেরাই বাড়িতে আগুন ধরিয়ে মিথ্যা অভিযোগ করছে। শ্যামল নিরপরাধ।”
