I am directed to inform you that Hon'ble Chairperson Shri Naparajit Mukherjee, West Bengal Human Rights Commission had a meeting in Burdwan with senior officials on 30th June, 2015. In the meeting it was reported by the senior officials that the physically challenged persons are being harassed because they are not getting their disability certificate and Block Medical Officers of the concerned Blocks are not aware of the fact that where those certificates will be procured. The bonafide physically challenged persons even do not know where to approach for their certificate.

So, I am directed to request you to kindly instruct the Chief Medical Officer of Health, Burdwan to look into the matter so that the physically challenged persons may get their Disability Certificate at the earliest possible time and the Block Medical Officers be sensitized about the matter with a copy to this Commission.
