The Commission taking cognizance on the complaint of one Ruma Maity of Purba Midnapur against the police personnel of Bally (Howrah) GRPS passed the following recommendation on 21.11.2014:-

1. Departmental proceedings be initiated against Lady SI Rupsina

Parvin, the on-duty officer of Howrah GRPS on 14.03.2014.

2. A sum of Rs. 20,000/- (Rupees twenty thousand) only in two equal

installments @ Rs. 10,000/- (Rupees ten thousand only) be

recovered from the salary of SI Rupsina Parvin and be paid to

complainant/victim Ruma Maity.

3. The Government should intimate the Commission about the action

taken or proposed to be taken on the recommendations within a

period of two months from the date of communication.

By their letter dated 04.11.2015 the Deputy Secretary to the Govt. of

West Bengal, Home Department, Human Rights Branch informed the

District Magistrate as follows:-

"I am directed by order of the Governor to say that on the basis of the

recommendation of the West Bengal Human Rights Commission, which

was accepted by the State Government, the Governor has been pleased to

accord sanction to the expenditure of a sum of Rs. 20,000/- (Rupees

twenty thousand) only to Ruma Maity, D/o. Sri Bhagawat Chandra

Maity, Vill. – Ektarpur, P.O. & P.S. – Bhupatinagar, Dist. – Purba Medinipur.

The Governor is further pleased to place an allotment of Rs. 20,000/-(Rupees twenty thousand) only at the disposal of the District Magistrate, Purba Medinipur, who will act as the Drawing & Disbursing Officer in this respect.

The amount sanctioned above may be disbursed to be above mentioned person on proper identification by the local civil authorities.

The charge on this account shall be debited to the head, "2235-Social Security and Welfare-60-Other Social Security and Welfare Programmes-200-Other Programmes-N.P.-Non Plan-015-Other Ex-gratia Payments-Voted-31-Grants-in-aid-02-Others Grants- V" under Demand No. 18 out of the current financial year's (2015-2016) budget provision.

This has the concurrence of Finance Department's Group-'N' U.O. No. 1798, dt. 13.10.2015 & Group 'D' U.O. No. Group – D/2015-2016/0421, dt. 16.10.2015.

After payment of compensation, an intimation with full address of the recipient along with the copy of receipted voucher and date of payment is to be sent by the District Magistrate, Murshidabad within 3 (three) weeks to this Department for onward transmission to the West Bengal Human Rights Commission as proof of compliance. Necessary order through e-bantan is being issued shortly.
